6.1 That the CAQ introduce a new by-law that the agenda for each council meeting be sent to all affiliated clubs at least one week before the meeting, and that the minutes of the meeting be sent to all the affiliated clubs within two weeks of the meeting taking place.

6.2 That the CAQ INC pay 50% of the ACF Australian Grand Prix fees, not including late fees, for events held by CAQ Affilated Clubs that are entered in the ACF Australian Grand Prix in 2015.

6.3 That the CAQ INC run a Queensland Participation Grand Prix in 2015, with total prizemoney of \$2000, and with all prize money to be won by CAQ Members only.

That this December 2014 AGM of the CAQ INC recommend that the 2015 CAQ INC Council support CAQ Affiliated Clubs with a \$300 subsidy to run Regional Week-Enders or a \$150 subsidy to run Week-Enders in South-East Queensland, and that the subsidy cheque be posted once the event entry form is placed on the CAQ Website.

For the purposes of this motion, Redcliffe, Brisbane, Logan, Sunshine Coast and Gold Coast Tournaments will be considered South-East Queensland Week-Enders and be entitled to a \$150 subsidy, and all other CAQ approved Week-Enders will be considered Regional Events and be entitled to a \$300 subsidy.
